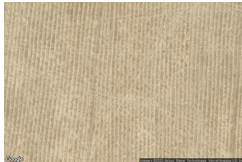


13 NOPAL BOULEVARD FRASER RISE VIC 3336

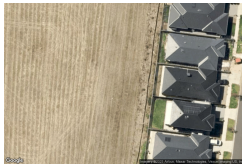
